Student 18 will also have to have a daily backpack check for the school year.

Discussion of financial reports:

Financial Reports as of July 31, 2021, presented by Travis Gostinger.

Travis states that as of July 31, 2021, Landmark's cash is 2.5 million and we are starting with a healthy cash position. This is the start of the trend that we typically see since we do not begin to receive state funds until sometime in October. We have 823 students currently enrolled, but that will change as we start the school year. Our budget is set at an enrollment of 775. The first Wednesday in October is count day. The audit is underway this week and there will be an audit presentation to the board, most likely in October. Sherry mentioned that Doug had a question, "what is the per pupil budget?" Travis informs that the budget they used was \$8,111 with a \$120 increase for \$8,231 and the actual that the state released is \$8,700. Kim Bowman asked if our online enrollment has grown. Debby answered that it is smaller, we have about 75 students in the online program this year so far.

3. Executive Leadership Update:

Adam Hoskins (K-5): Adam informed the board that he is settling into his principal role. Flooring projects in the building has made for an interesting summer school but they juggled the room changing well. He will be staying on as the Athletic Director this year and hopefully transiting to the Assistant Athletic Director. The kindergarten readiness event was a huge success, they had nearly 100% participation. Tuesday's Open House went well, lots of positive feedback from K-2 parents. Tonight, is the 3-5 Open House. Elementary is starting a Leader in Me program that is student driven, with student leadership and encouraging students to take a more active part in their school. Our athletic program has a sports resolution for MHSAA that needs board approval to adopt Michigan high school sports bylaws.

The carpet is here for the hallways, it will be installed later this year.



Orientation is tonight from 1 to 6pm. There will not be pictures, Lifetouch had to cancel.

We need the board to approve the handbooks and course catalogs. Landmark Academy high school is offering A.P. Government this year. Kim Bowman had some questions on the dress code regarding earrings and hairstyles. Debby explained that the middle school dress code and the high school dress code are different with regards to hair. High school students can have the tips of their hair, or a strip of hair colored an unnatural color. The earrings rule was change several years prior. Kim asked why the difference in dress codes and Debby explained that high school dress code is different because they are older and they do not have to wear a uniform, they can wear jeans every day. Kim also asked about if you miss more than 1 and a half hours it is an unexcused absence, what about appointments. Debby explained that this does not include appointments, doctors and dentists will give students a note to bring to school that explains they were at an appointment, then the absence is excused, not unexcused.
