Discussion of Finance Reports

Financial Reports as of March 2023, presented by Lori LaMontagne

3. Executive Leadership Update (40 minutes)

Adam Hoskins (K-5): MSTEP testing is finishing. The Elementary McTeacher night was a success. We are prepping for end of the year field trips and the math intervention teacher has been hired. Currently we are working on a SVSU project "LA Academic Hub", one central location for data. This will allow staff to review all test data in one location. We will be presenting this project on May 12 at SVSU.

Debby Wilton (MSHS): Landmark unexpectedly lost a teacher. Out of respect for the teacher, her family, and our staff, Landmark made the decision to close school the day of her funeral. Debby checked with RESA on our school calendar, and we still had one day that we could use for forgiven time. Kim Bowman asked how the students were handling the teacher's passing. Adam explained that since this was a second-grade teacher, we sent home a communication to the parents so they could decide what to tell their child.

MSHS is working on testing and wrapping up make-up testing this week. Then we will start with NWEA testing. Charter school week is coming up. The student council has planned dress down days and an assembly at the end of the week. A few teachers along with a group of students, Debby and Travis will be going to the capitol the Wednesday of charter school week. Also, during May, our social worker is doing a week of mental health awareness.

Teacher evaluations are coming up along with end of the year field trips. May is also the last month for our seniors with lots of events for them: class trip, last week, exams, beach day, final walk, and graduation. Josh Chapman will be the speaker at graduation.

4. Board Strategy & Planning (20 minutes)

Approval for the policy changes will be brought up at the May board meeting.
