Adam Hoskins (K-5): Elementary has almost finished M-Step testing. Between now and the end of the school year each grade will be taking a field trip along with Safety Patrol and the Laker Leadership team. Students are working on their student leadership portfolios. During conferences they used them to lead their parent/teacher conference.

Tom Gostinger (MSHS): Our students have completed the PSAT, SAT and WorkKeys. Next, we will begin to start NWEA testing. Students will get a goal score based on growth and can earn certificates and rewards. We have 5th grade and 8th grade transition activities scheduled to help those students get a glimpse of what middle and high school is like. There are also a few field trips coming up for some classes. Charter school week is next month. May is also a busy month for our HS seniors. Several end of the year activities will happen as they prepare for graduation. Our art teacher, Ms. Stocks, is helping to ensure that the set for the ceremony will be beautiful. Kim asked if the seniors walked through the elementary or just the middle/high school. Debby replied that they do not walk through the elementary but that is something that they can think about for next year. Jeff added that he likes all the extra efforts he sees. It is what makes Landmark so great.

Kim asked about the virtual reality program. Further discussion commenced.
